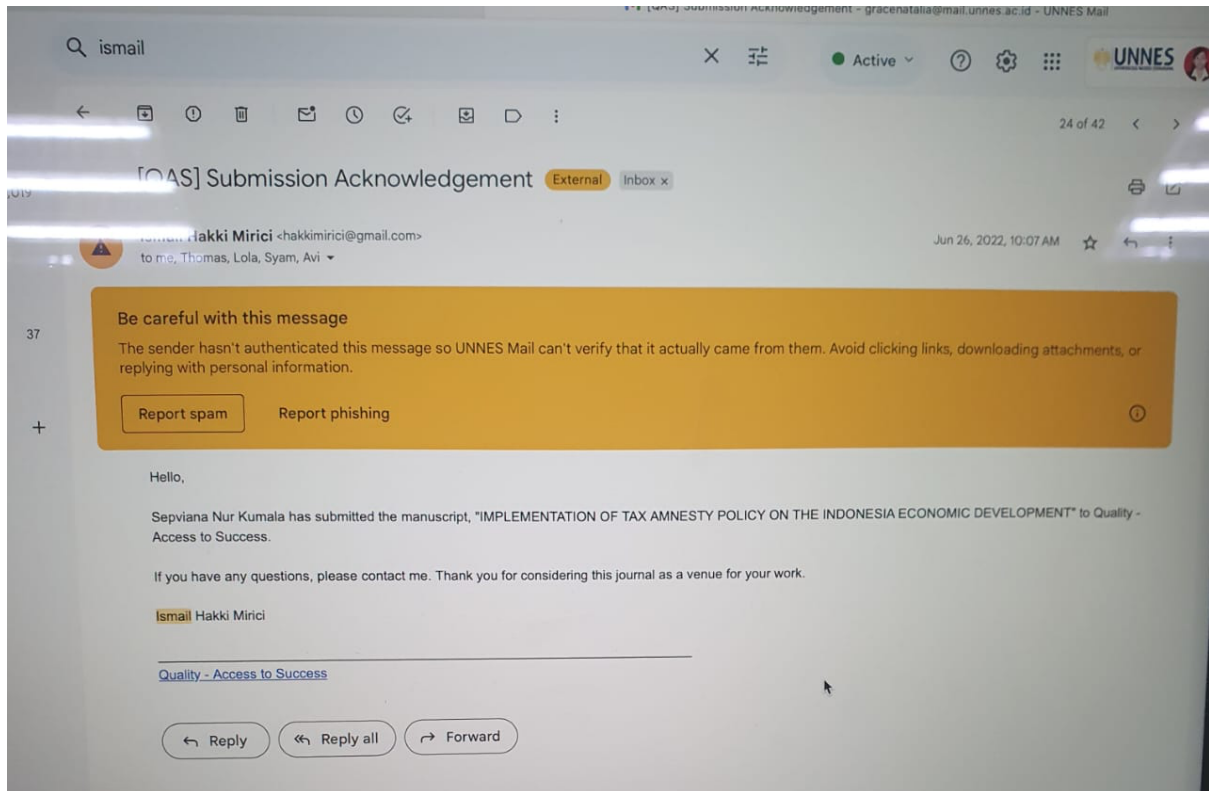

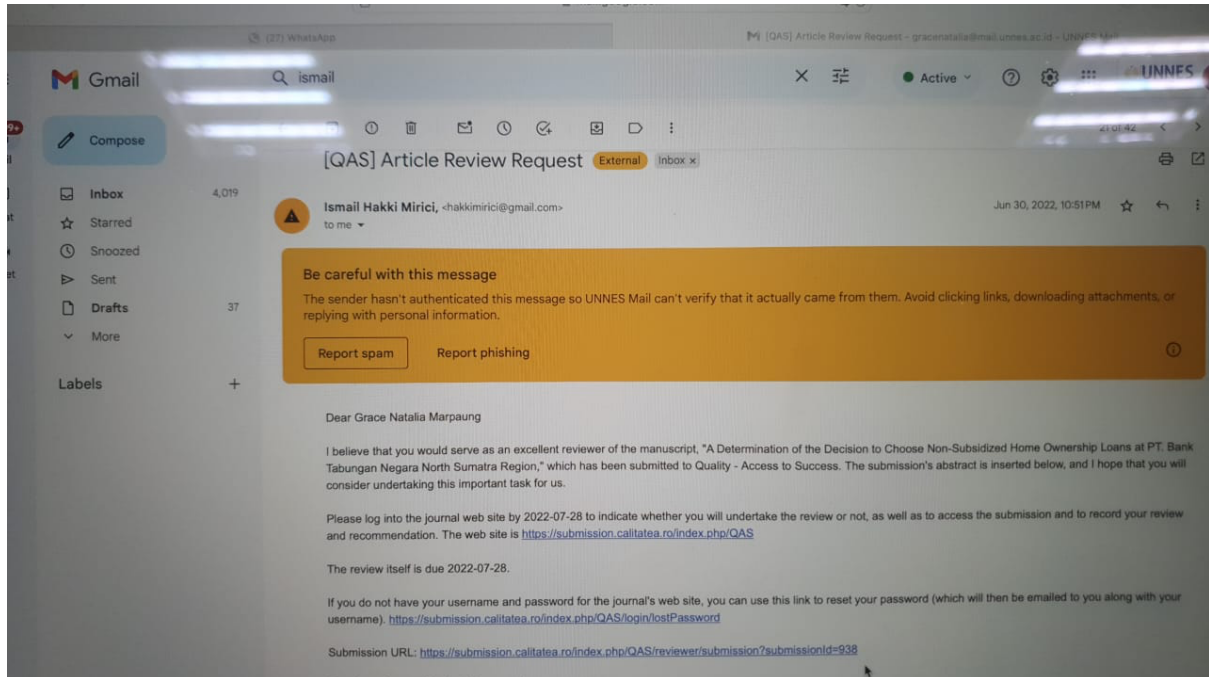

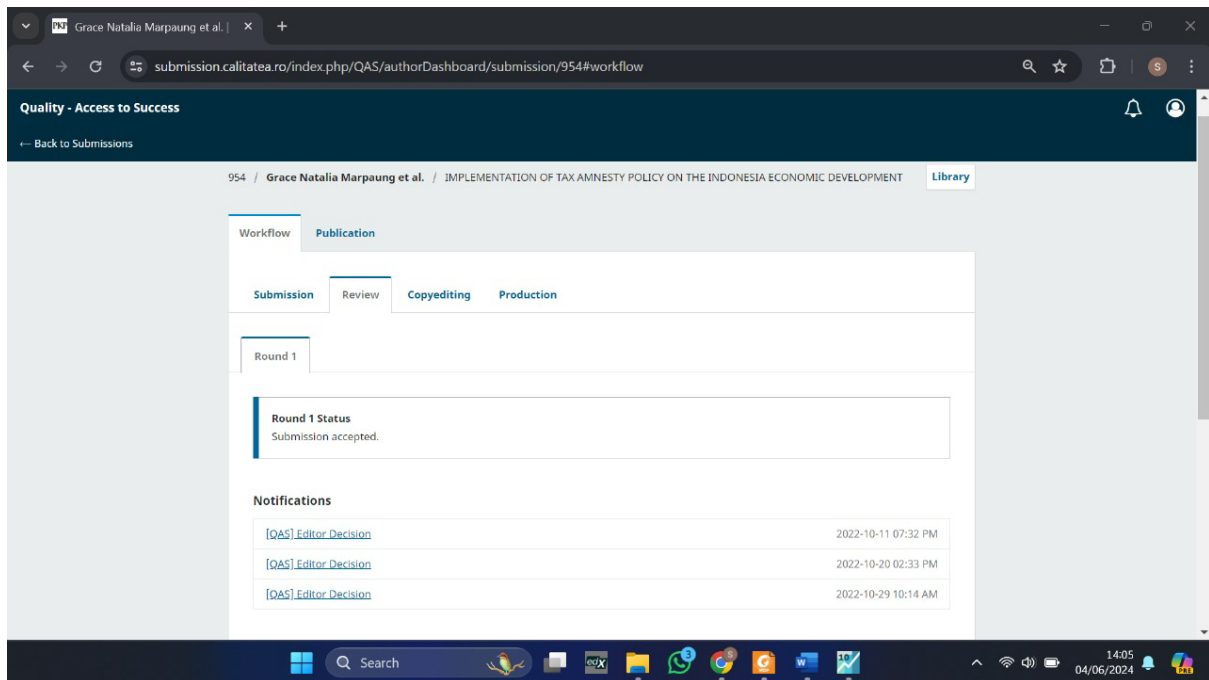

2. Abstract: it is necessary to be more systematic in compiling abstracts consisting of the need for this research to be carried out (what is the problem on the Indonesian economic development), research objectives, methods used, and research results
3. Introduction: it is necessary to include a statement of the contribution of the novelty of the research which is strengthened by an overview of the literature as evidence that this research has never been done.
4. Background Theory and Hypothesis: It is necessary to add the theoretical basis used and its relationship to the problem under study.

Research questions need to be simplified and focus more on research gaps. The hypothesis needs to be supported by theory and previous research.

5. Method: It is necessary to focus on the determination between the analytical tools used and the problem to be studied. Different tests can be considered to answer research questions point a.
6. Reference: need to add more Scopus indexed reference topics. You can use the <http://sci-hub.se> site to download Scopus indexed articles.

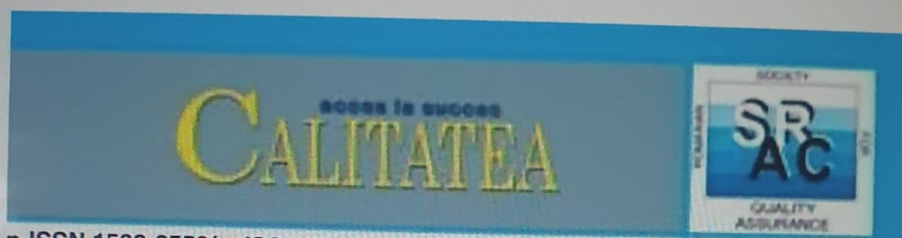
